Presidents Report

- Still getting more information for EFA (educational freedom account) sign up is in June. If signing up as a vendor will cross over as extracurricular activities - 25% can be used for supplies (skates, costumes, etc.) but doesn't cover comp fees

Treasurer Report

- Starting: \$32,402.19
