### **Jones Center Covid-19 Vaccination Policy**

## **US Figure Skating Path to Coaching Compliance**

Coaches must complete their coach registration by July 1 to be compliant for the new season, per MR 5.11. 1. **Any renewing coach who does not fulfill the requirements of coach compliance by July 1 will be assessed a \$75 late fee by USFS.** Requirements include: US Figure Skating membership background check, liability insurance, CER's, SafeSport training, and PSA membership. **For more information visit: <https://www.usfigureskating.org/support/coach/coach-compliance>**

### **Completion of CERs <https://skatepsa.com/elearning>**

- All coaches will choose one module and all required learning takes place in that one module.
- Prior to July 1, **the cost is \$70.** After that time, the price will go up
- PSA says not to use Safari, as their testing system is not compatible. There have been reports of coaches taking the test via Safari and the results not being recorded.

### **Learn to Skate Instructor Renewal (Don't begin until June 1)**

- Do Learn to Skate first to save money because the background check is included in the LTS instructor membership!! [www.learntoskateusa.com](http://www.learntoskateusa.com)
- Use your current USFS number for this **DO NOT CREATE A NEW LTS NUMBER**, otherwise you will be charged for your background check twice.
- Click on the "log in" button on the top right and use your membership number and password from USFS/LTS. If you do not know your password, click on "forgot password" so that a temporary one can be emailed to you.
- On the top will be a red box inviting you to renew your membership or join now. Make sure during the process when it asks if you are an instructor this year, mark yes! (This will be at the bottom of the page where address/info verification is done)
- Renew/create your membership then an email will be sent to you to take the Litmos certification if you are under 18 years old and SafeSport certification if 18+ years old within 1-2 hours after renewal. When logging into SafeSport please do not use the "L" in front of the number.
- You will also be charged for a background check if you are 18 years and older. If you already paid for a background check on USFS, you will not be charged/prompted to do another one. If you are under 18, you are not required to have one. **The cost is \$39.25**
- **NEW FOR 2021-2022 LTS instructor course will now be mandatory for all Learn to Skate USA instructors in order to be compliant. Previously, the course was only required for instructors under the age of 18.**

### **Background Check (Don't begin until June 1)**

- See LTS above, we recommend you do this via LTS with instructor renewal. It can be done with PSA, but it is included with LTS if you do that step first.

### **Liability insurance (Don't begin until June 1)**

- Log in to USFS, go to Members Only (top right) and then the Compliance/Safe Sport button <https://www.usfsaonline.org/>. This can also be purchased through PSA- See number 6 below.
- **Cost is approximately \$100**

### **SafeSport training**

- Training is accessible through Members Only on USFS website under the safe sport/compliance tab and is **free**.

### **Register as a coach**

- Go to the member's only section on USFS website and log in, go to account on the top right corner and select Member Profile and then edit. Click that you are a coach.

### **Professional Skaters Association**

- You'll need to purchase a PSA Membership. <https://skatepsa.com/>
- New Full memberships **cost \$115**, Returning Full memberships are **\$130**
- If you are a junior coach, talk to Chelsea or Toni about which membership you need.

### **Items to give to Chelsea or Toni before July 1**

- **LTS Instructor Certification, proof of insurance, Safe Sport Certificates, PSA/CER certificate, and a photo of your green checkmarks from your general compliance box in your USFS SafeSport page.**

**Total Approximate Cost: \$400 for full coaches**
