## **I. COMPETITION OVERVIEW**

The Skate Tulsa 2025 will be conducted in accordance with the rules and regulations of U.S. Figure Skating, as set forth in the [current rulebook](#), and/or [current Compete USA handbook](#) as well as any pertinent updates that have been posted on the U.S. Figure Skating [website](#).

This competition is open to all eligible, restricted, reinstated or readmitted persons as defined by the Eligibility Rules.

Skaters must be a currently registered member of a U.S. Figure Skating member club, (if offering Compete USA events) Learn to Skate USA® member, a collegiate club or who is an individual member

in accordance with the current rulebook. For non-U.S. citizens, please refer to the [rulebook](#) for more information.

## **II. ELIGIBILITY**

### **Singles: Excel and Well-Balanced Events:**

- Skaters must meet at least the minimum singles test requirements for the event's level. A skater's singles test level may be higher than the minimum requirement.
  - o Skate Up: skaters may skate up one level higher than their minimum test requirement allows.
- Skaters may not register for an event level lower than allowed by their competitive floor. An athlete's competitive floor is set by one of the following scenarios:
  - o If an athlete has a paid EMS series application for the NQS series, the event level registered for in the most recent NQS will become the lowest level they may compete at in any U.S. Figure Skating sanctioned event.
  - o If an athlete has a paid EMS series application for the Excel Series, the event level registered for in the most recent Excel series will become the lowest level they may compete in any Excel event. For Well-Balanced and Specialty events the skater will be permitted to register at one level lower than the "floor" set by their excel series entry.
  - o If an athlete has never had a paid EMS series application in the NQS or Excel series, the athlete may select their level based on their goals and technical skills as long as the minimum test requirements are met.
- Skaters are not permitted to enter an Excel free skate and a Well-Balanced free skate event at the same competition (example: Juvenile Girls Free Skate and Juvenile Girls Excel Free Skate). However, they are permitted to enter an Excel and a Well-Balanced event of different types such as a short program (if stand-alone event option), specialty or showcase events (example: Intermediate Women Short Program and Intermediate Women Excel Free Skate).

### **All other singles and partner events (such as Adults, Pairs, Ice Dance):**

- Skaters must meet the minimum test requirements for the events level, but not exceed the maximum permissible test requirement.

### **COACHES**

To be an eligible coach at a nonqualifying competition, coaches must meet the applicable compliance requirements and verified by U.S. Figure Skating. Coach compliance falls into two categories, Coach Compliance (includes choreographers) and Learn to Skate USA® Instructor Compliance. Details regarding compliance requirements can be found [HERE](#). All compliance requirements must be met at the time of check-in to access the competition, no exceptions.

Coaches of foreign athletes: If you are a coach of a foreign athlete only, you are not subject to U.S. Figure Skating coach compliance and will only be asked to provide a letter of good standing for the federation your athlete represents.

There will be a limit of one (1) credentialed coach per athlete.

### **TEAM SERVICE PERSONNEL**

Teams are permitted a maximum of two team service personnel. Team service personnel must have a current U.S. Figure Skating or Learn to Skate USA® membership, a green lighted background check and completed SafeSport™ Training. All compliance requirements must be met at the time of check-in to access the competition, no exceptions. Team service personnel is defined as those indicated as a team manager and/or team service personnel planning to attend the competition with the team.

### **MANDATORY ATHLETES**

Athletes age 18+ as of the competition start date who will be competing on a team (i.e., synchro, ice dance, pairs, shadow dance, theatre, etc.) with at least one Minor Athlete must complete SafeSport™ Training. \*

Minor athletes who turn 18 mid-season are encouraged to seek parental consent to take the online SafeSport™ Training early to avoid any disruptions in their ability to participate as the training is required upon turning 18. The athlete will not be compliant until they have completed the training and their Members Only portal reflects completion. Please email [skatesafe@usfigureskating.org](mailto:skatesafe@usfigureskating.org) for instructions or questions regarding parental consent.

### **III. REGISTRATION INFORMATION**

Skate Tulsa 2025 is using EntryEeze for online registration.

Registration Deadline is June 8, 2025

Late registration will be at the consideration of the referee and the LOC Chair. If a late registration is allowed, there will be a late registration fee of \$50 per event requested. Maximum of \$150 late fee. Tulsa Figure Skating Club reserves the right to close registration at any time if event capacity is met.

### **PARTNERED EVENTS:**

Both partners will need to go into EntryEeze and register for the events. EntryEeze treats partnered events as a team event so look under team events for the traditional partnered events. During the registration process, EntryEeze will ask you for your partner. Both partners will be asked to upload music. However, only one is required to do so. If you have any questions, please do not hesitate to reach out to the competition chair via email to address them.

### **FOREIGN SKATERS:**

Non-U.S. skaters intending to register for this competition need to reach out to the LOC Chair prior to registration to ensure that all eligibility requirements have been met. Please email [george@tulsafsc.com](mailto:george@tulsafsc.com) and clearly state that you are a non-US skater registering for skate Tulsa.

### **TEST CREDIT:**

There will be a test credit packet available for a nominal fee at the competition along with the guidelines and process. If you are seeking test credit, there will be a testing fee of \$50 that must be paid at the time of the test request. This fee will be paid at the competition, prior to the end of the competition in accordance with the test credit guidelines.

### **CRITIQUES/FEEDBACK**

Critiques will be offered at Skate Tulsa 2025. You must be registered in an IJS event for a critique. If you would like a critique, please purchase a critique session in the event store on EntryEeze. Once we have the schedule finalized and know which judges will be judging which event, we will schedule the

critiques.

**MUSIC SUBMISSION/UPLOAD:**

All music must be uploaded on EntryEeze not later than 7/1/2025. Failure to upload music on EntryEeze may result in a penalty of \$50/event that requires music. Please pay attention to the messages concerning music especially as we get close to the event. If we combine show case events, sometimes EntryEeze “looses” the music and it has to be reuploaded so please pay attention.

Competitors must also have available a backup copy of their competition music on a cell phone and it must be immediately available rink-side whenever the skater competes. If the phone does not have the standard round headset connector, an appropriate adapter, such as an Apple Lightning connector or Samsung USB-C adapter is required to be attached. The phone should be presented to the music person with the file ready to play, phone in airplane mode and volume turned to maximum.

We will not have the ability to play music from a CD.

**PLANNED PROGRAM CONTENT (PPC) SUBMISSION/UPLOAD – FOR IJS EVENTS ONLY:**

PPC shall be uploaded on EntryEeze. Please pay attention to the messages from EntryEeze for uploading PPC. PPC must be uploaded not later than 7/1/2025. Failure to upload PPC on time may result in a penalty of \$50/event that requires PPC.

**REFUND POLICY**

Refunds will be on a case by case basis and must be made in writing (e-mail) to the registration chair. Entry fees will not be refunded after entry deadline unless no competition exists or the event is canceled. There will be no refunds for medical withdrawals.

**LIABILITY:**

U.S. Figure Skating, Learn to Skate USA, Tulsa Figure Skating Club and WeStreet Ice Center accept no responsibility for injury or damage sustained by any participant in this competition. This is in accordance with Rule 1600 of the official U.S. Figure Skating Rulebook.

**IV. COMPETITION DETAILS**

**FACILITIES:**

Tulsa Figure Skating Club, The Tulsa Oilers and WeStreet Credit Union is very proud to introduce the new WeStreet Ice Center. WeStreet features two sheets of NHL ice, concessions, locker rooms, and work out space. We will be using a single sheet for Skate Tulsa 2025. The second sheet will be available for skaters to purchase free skate and public skating time. Stay tuned to [www.tulsafsc.com](http://www.tulsafsc.com) for information as WeStreet is not even open yet.

**LOCKER ROOMS AND CHANGING AREAS:**

We expect to have a limited number of locker rooms available for changing.

Locker rooms and changing areas at U.S. Figure Skating competitive events are for athletes only, will be labeled with regard to specific use and where identified will be gender specific. An exception can be made for athletes under 11 years old that will allow for one parent of the same sex to assist their child immediately prior to and after their skating event(s). Please review the Locker Room and Changing Area Policy in the [SkateSafe® Handbook](#).

#### TEAM LOCKER ROOMS:

The designated team coach, team manager, team service personnel and athletes competing at the skating event are allowed in the Locker Rooms/Changing Area designated for their team. The team coach, team manager, and team service personnel should remove themselves from the Locker Room/Changing Area while any Minor Athlete(s) are actively changing or undressing. All Locker Rooms/Changing Areas will be monitored. If any concerns arise, immediately contact the Locker Room/Changing Area monitor. If there are concerns regarding this policy, an athlete should change prior to arriving at the competition. The use of any recording and photographic devices inside a Locker Room/Changing Area is strictly prohibited. Any violation of this policy is punishable under the U.S. Figure Skating SkateSafe® policy and U.S. Figure Skating Rulebook.

#### **U.S. Figure Skating Travel Policy:**

All travel must strictly adhere to Two-Deep Leadership requirements. An Adult Participant cannot transport a Minor Athlete one-on-one and Two-Deep Leadership requirements must be adhered to at all times during In-Program travel, by transporting at least two minors or a second Adult Participant. An Adult Participant cannot share a hotel room or other sleeping arrangement with a Minor Athlete(s). - EntryEeze will be used to manage all aspects of this event. Please login and check frequently for schedules, updates, messages, etc.
- Emails will be sent via EntryEeze to all registered participants in the event to communicate changes and updates as needed.

- We will setup online scoring for the event. A QR code will be provided at check-in.
- It is the responsibility of each competitor, parent and coach to check the website ad to pay attention to the communications coming from EntryEeze frequently for any schedule changes and/or additional information pertaining to the competition.

#### **SCHEDULE**

Competitors may be scheduled on any day or time during the announced dates of the competition. The competition and practice ice schedule will be available after the close of entries. All participants will be notified via email once available.

#### **PRACTICE ICE:**

Practice ice will be sold on EntryEeze at \$20/20 minute session. The only way to get practice ice is to purchase it on EntryEeze. We will schedule your practice ice for you based on when you skate, availability, skill level, etc. There is no official practice ice, ie we will not be playing program or dance music on any practice ice. Initially you may only purchase two practice ice sessions online. We will try to schedule practice according to level and the time of your event. There may be additional practice ice sold at the event for cash at the event.

### **ONSITE CHECK-IN:**

Check-in will open one hour prior to the first scheduled event. Check-In will be in the lobby of WeStreet Ice Center. Check-In will close one hour prior to the last event of the day.

### **AWARDS:**

Awards will be offered for places 1-6 in all events. Metals for places 1-3 and ribbons for 4-6 are planned. Awards will be distributed on site. Please make plans to pickup your award prior to departing the event. We will not be mailing or otherwise distributing any awards not picked up.

### **VOLUNTEER INFO:**

It takes many many many volunteers to put on an event such as Skate Tulsa.
